Pursuant to points 2 and 3 of Article 58 of the Banking Act (Official Gazette of the Republic of Slovenia, No. 25/15; hereinafter: the ZBan-2) and the first paragraph of Article 31 of the Bank of Slovenia Act (Official Gazette of the Republic of Slovenia, Nos. 72/06 [official consolidated version] and 59/11), the Governing Board of the Bank of Slovenia hereby issues the following

REGULATION

on the documentation for demonstrating fulfilment of the conditions for nomination as a member of the management body of a bank or savings bank

Article 1 (content of regulation)

- (1) This regulation sets out the detailed content of the documentation by means of which:
- 1. a candidate to be a member of the management board of a bank or savings bank (hereinafter: bank) in a two-tier governance system or an executive director of a bank in a single-tier governance system, to be the liquidator of a bank or to be the managing director of a branch of a third-country bank (hereinafter: candidate for membership of the management board) demonstrates that the conditions set out in Article 38 of the ZBan-2 have been fulfilled, or
- 2. a bank demonstrates that the conditions for nomination as a member of the supervisory board set out in Article 53 of the ZBan-2 have been fulfilled in connection with a nominated member of the supervisory board of a bank in a two-tier governance system or a non-executive director of a bank in a single-tier governance system.
- (2) Wherever this regulation makes reference to the provisions of other regulations, these provisions shall apply in their wording applicable at the time in question.

Article 2 (use of terms)

The terms used in this regulation shall have the same meanings as in the ZBan-2 and Regulation (EU) No 575/2013, and in regulations issued on their basis.

Article 3 (enclosures in connection with demonstration of fulfilment of conditions)

- (1) A candidate for a member of the management board shall also enclose the following in the request for the granting of the authorisation referred to in the first paragraph of Article 40 or in connection with Article 80 and the second paragraph of Article 122 of the ZBan-2:
- 1. a completed VPR questionnaire, which is an appendix to this regulation, in the part relating to a candidate for a member of the management board;
- 2. an extract from the criminal records or another form of evidence of the fulfilment of the condition set out in point 2 of the first paragraph of Article 38 of the ZBan-2;
- 3. a declaration by the candidate for a member of the management board or appropriate assurances with regard to the fulfilment of the condition set out in point 3 of the first paragraph of Article 38 of the ZBan-2;
- 4. the decision by the supervisory board on the nomination of an individual as member of the management board referred to in the third paragraph of Article 39 of the ZBan-2.
- (2) Within five days of the nomination of a member of the supervisory board at the Assembly meeting, the bank shall submit the following to the Bank of Slovenia in connection with the person in question:

- 1. a VPR questionnaire, which is an appendix to this regulation, in the part relating to a nominated member of the supervisory board, completed by the member in question;
- 2. an extract from the criminal records or another form of evidence of the fulfilment of the condition set out in point 2 of the first paragraph of Article 53 of the ZBan-2;
- 3. a declaration by the member of the supervisory board or appropriate assurances with regard to the fulfilment of the condition set out in point 3 of the first paragraph of Article 53 of the ZBan-2;
- 4. the decision by the bank's Assembly on the nomination of the member of the supervisory board.

Article 4 (cessation of application of regulation)

On the day that this regulation enters into force, the Regulation on the documentation for demonstrating fulfilment of the conditions for performing the function of a member of the management board of a bank or savings bank (Official Gazette of the Republic of Slovenia, Nos. 74/13 and 5/14) shall cease to be applied.

Article 5 (entry into force)

This regulation shall enter into force on the day after its publication in the Official Gazette of the Republic of Slovenia.
